Boards of Education have a statutory duty to charge tuition to the parents or guardians of non-resident students. In Harlem School District No. 122, parents/guardians are required to verify that they reside within the boundaries of the District and of the specific school to which they attend. **A person who knowingly or willfully presents to the Harlem School District any false information regarding the residency of a student for the purpose of enabling that student to attend any school in the District without the payment of a nonresident tuition charge is guilty of a Class C Misdemeanor (105 ILCS 5/10-20.12.b(f)).**
