There is a need to increase the existing .5 FTE ELL Coordinator working a 205 day contract to a 1.0 FTE ELL Coordinator working a 215 day contract in order to meet the needs of our ELL students and due to summer responsibilities and expectations in preparation for our English Language Learner Program. This increase will result in the need for the posting of a .5 FTE Elementary Assistant Principal at Rock Cut Elementary School.

There is a need for an additional Para Educator at Maple Elementary due to the enrollment of a new student who requires individual assistance in order to meet IEP compliance. This will be a terminal position for the remainder of the 2017-2018 school year.
