NEW POSITION

Half-time School Social Worker – Harlem Middle School

The administration is recommending the addition of a .5 FTE School Social Worker at Harlem Middle School as a result of the resignation of the School Psychologist at Harlem Middle School. The school psychologist position will be covered with a contracted psychologist via Vocovision to complete evaluations for special education eligibility. The workload for the counseling and completing functional analysis and behavior intervention plans will be covered with the .5 FTE School Social Work position.
