NEW POSITIONS

1.5 FTE - SCHOOL SOCIAL WORKERS

After reviewing building populations, SES percentages, mobility rates, 504 and IEP needs, it has been determined that there is a need to increase the overall support for Social Worker services in order to allow the District to continue providing SEL supports, trauma informed practices training, and direct mental health services to better meet the needs of our students. 0.5 FTE will be funded through the Preschool for All grant and will be assigned to Maple Elementary in order to support the preschool program there. 0.5 FTE will be added to both



Loves Park and Windsor Elementary to bring their Social Worker staffing to 2.0 FTEs at each building. This increase is needed in order to balance the workload in comparison to other buildings in the District.
